Veterinary medical supply costs and quantities have incrementally increased over the past few years.

Animal Resources must provide a variety of different medications and surgical interventions including spay/neuter surgeries, core vaccinations, parasite treatments and many others. Animal resources must also perform different tests for diagnostics, all to better or save the lives of animals that come into our care each year.
