

**SECOND AMENDMENT AGREEMENT WITH BLACKHAM CONTRACTING GROUP, LLC
FOR ANNUAL MOWING AND TRIMMING FOR CONSERVATION LAND NO.14099**

THIS SECOND AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and Blackham Contracting Group LLC, which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS the Parties previously entered into a Contractual Services Agreement dated February 15, 2024 for Annual Mowing and Trimming for Conservation Land, identified by No. 14099 (the "Agreement"); and

WHEREAS the County Parties previously entered into the First Amendment to the Agreement, dated August 15, 2024, which extended the term of the Agreement through September 30, 2026 (the "First Amendment"); and

WHEREAS, the County desires to modify the scope of work to increase the services in one of the covered areas, specifically Sweetwater Preserve; and

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

A. The Table in Exhibit #1 of the Agreement titled Typical Work Description is amended to modify the work for Sweetwater Preserve Trailhead to read as follows:

B. Exhibit #2 of the Agreement titled Rate Schedule, is amended in its entirety and replaced with an updated Exhibit 2 attached to this Amendment

C. Effective Date. This Amendment shall be effective upon execution by both the Parties.

D. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.

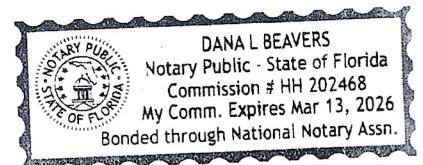
