PETITION BY SPRINGHILLS NORTH COMMUNITY DEVELOPMENT DISTRICT TO THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, FOR THE TERMINATION AND DISSOLUTION OF THE SPRINGHILLS NORTH COMMUNITY DEVELOPMENT DISTRICT BY REQUESTING REPEAL OF ORDINANCE NO. 22-11 PURSUANT TO SECTION 190.046(10), FLORIDA STATUTES

By and through its undersigned counsel, the Springhills North Community Development District (the "District"), hereby petitions the Board of County Commissioners of Alachua County to enact an ordinance repealing Ordinance No. 22-11 and dissolving the District pursuant to Chapter 190, *Florida Statutes*.

- 1. The District is a local unit of special-purpose government organized and existing in accordance with the Uniform Community Development District Act of 1980, Chapter 190, Florida Statutes, as amended, as created by Alachua County Ordinance No. 22-11, adopted May 24, 2022.
- 2. The original petitioner for the establishment of the District had intended to develop the real property within the District and to have the District plan, construct, and maintain facilities for residents of the District.
- 3. The property was not developed, no improvements were constructed by the District, there are no outstanding financial obligations of the District, and there are no operating or maintenance responsibilities of the District. See affidavit of District Chair attached as **Exhibit A.**
- 4. The need for the District no longer exists and the sole-landowner within the District consents to the dissolution of the District. See Landowner Consent attached as **Exhibit**B.

5. The District's Board of Supervisors (the "Board"), met on April 4, 2025, at

a duly noticed public meeting and adopted Resolution 2025-01, which among other things,

declared the District to be inactive and authorized its attorneys and representatives to petition the

Board of County Commissioners for dissolution of the District. A copy of Resolution 2025-01 is

attached to as Exhibit C.

Any administrative expenses associated with this dissolution are being funded

pursuant to a third-party payor agreement with the Landowner. As such, all outstanding

obligations of the District have or will be paid.

7. Upon dissolution of the District, the District will cause all official records of the

District to be transferred to the Florida Secretary of State.

8. Upon the dissolution of the District, the District will cause notice of the

dissolution to be transmitted to the Florida Department of Commerce and will further cause a

Notice of Dissolution to be recorded in the Official Records of Alachua County, Florida.

Therefore, because the District has no outstanding financial obligations and no

operating or maintenance responsibilities, and accordingly has met the requirements for

dissolution as provided in Section 190.046(10), Florida Statutes, and for the other reasons

herein stated, Petitioner respectfully requests the Board of County Commissioners to enact a

non-emergency ordinance repealing Ordinance No. 2022-11 and dissolving the District.
