Novation and Second Amendment 13701 with United Structural Systems, LLC d/b/a Foundation Services of Central Florida, Inc., for Bid 23-230 Annual Subsurface Injection and Grout Services, not to exceed (NTE) \$60,000.00 annually for Public Works. Foundation Services of Central Florida merged with United Structural Systems, LLC on 4/102025. This Amendment extends the term through September 30, 2027.

February 28, 2023, the Board approved the Solicitation Award and Contract for Bid 23-230 Annual Subsurface Injection and Grout Services, to Foundation Services of Central Florida, Inc., not to exceed (NTE) \$60,000.00 annually, to repair sinkholes for Public Works. Item 23-0435.

#### **Fiscal Note:**

The agreement includes an annual not-to-exceed amount of \$60,000 annually. Funds for repairs are in account 149.79.7900.541.46.00 in the Gas Tax Operations Fund or Capital Project Funds as needed.

## **Background:**

Subsurface injection and grouting is a service needed by Public Works in order to conduct underground repairs to sinkholes, roadways, and drainage structures/pipe. This method of repair reduces or eliminates the amount of excavation required and thereby reduces impact to existing facilities. Under this contract repairs can be completed in a timely manner without conducting the procurement process for each instance where work is needed.

BID 23-230 Annual Subsurface Injection and Grout Services advertised on September 14, 2022. The deadline for receipt of Bid 23-230 Annual Subsurface Injection and Grout Services was October 12, 2022; three (3) vendors responded..
