

**FIRST AMENDMENT TO AGREEMENT
FOR ANNUAL RIGHT-OF-WAY MOWING WITH
ALLEN JONES LANDSCAPING, LLC, #13801**

THIS FIRST AMENDMENT (“Amendment”) is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the “County”) and Allen Jones Landscaping, LLC, a Florida limited liability company which is authorized to do business in the State of Florida (“Contractor”), who are collectively referred to as the “Parties”.

WITNESSETH:

WHEREAS, the County and Contractor previously entered into an Agreement dated April 18, 2023, for Annual Right-of-Way Mowing Services for Alachua County Roads, identified by No. 13801 (the “Agreement”); and

WHEREAS, the County has elected its option to renew the term of the original Agreement to allow the Contractor to continue to furnish the goods or services to Alachua County; and

WHEREAS, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

A. Amendment. Section #3, of the Agreement titled “Term” is amended to read as follows:

3. **Term**. This Agreement is effective upon execution (“effective date”) and continues until September 30, 2025, unless earlier terminated as provided herein. This Agreement may be amended at the option of the County for 1 additional one-year term at the same terms and conditions outlined herein.


B. Effective Date. This Amendment shall be effective upon and after full execution of this Amendment by the Parties.

C. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.






