### **Description:**

First Amendments to Agreements with Bird Dog Fire and Land Management (14087), Blackham Contracting Group, LLC (14088) Promise Habitat Services LLC (14091), R.O.T. Ranch Construction Inc. (14092) for Annual Fireline Road and Fuels Treatment Projects for Environmental Protection. This amendment increases the Not to Exceed (NTE) from \$150,000.00 to \$400,000.00 Annually.

January 9, 2024, the Board approved the Award of Bid 24-63 Annual Fireline Road and Fuels Treatment Projects to Bird Dog Fire and Land Management Inc., Blackham Contracting Group, LLC, Creative Concrete Design of Columbia County Inc., GRSC, Inc., Promise Habitat Services, LLC, and ROT Ranch Construction, Inc. Item #24-00047.

**Fiscal Note:**

The addendum agreements have a NTE of \$400,000 Annually, the account codes will vary based on the project. There are sufficient funds available in the departmental budget to cover these expenses.

**Background:**

Of the originally contracted vendors, GRSC, Inc. (14090) has since been terminated due to inability to complete work and Creative Concrete Design of Colombia County, Inc. (14089) has declined to increase the Not to Exceed amount at this time.

Bid 24-63 Annual Fireline Road and Fuels Treatment Projects summary:

The Fuel Treatment project goal is to reduce the stature and alter the arrangement of wildland fire fuels in an area to increase safety during fire operations and improve smoke management issues. The Fireline and Road projects goal is to create and maintain drivable and defensible firelines and roads within Alachua County lands for the purposes of prescribed burning, wildfire protection and other stewardship activities.

Bid 24-63 Annual Fireline Road and Fuels Treatment Projects was released September 6, 2023. The deadline for receipt of Bid 24-63 Annual Fireline Road and Fuels Treatment Projects was October 4, 2023; seven (7) vendors responded.
