A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, TO RECOGNIZE UNANTICIPATED REVENUE FROM THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (FDEP) AND NEIGHBORING COOPERATIVE COUNTIES (COOP) FOR HOUSEHOLD HAZARDOUS WASTE EVENTS, AUTHORIZE EXPENDITURES FROM SAID FUNDS, AND PROVIDE AN EFFECTIVE DATE.

Whereas, it is necessary to receive unanticipated revenue from the FDEP and COOP in the FDEP Hazardous Waste COOP Fund;

1. That the fiscal year 2024-2025 Adopted budget is hereby adjusted as reflected in the budget amendment attached hereto.
2. By adoption of this resolution and the attached budget amendment, the Board of County Commissioners of Alachua County, Florida, hereby accepts FDEP and COOP Grants and appropriates them as outlined in said amendment.
3. That this resolution shall take effect immediately upon its adoption.
