**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA; AUTHORIZING THE CHAIR TO EXECUTE ANY STATE HOUSING INITIATIVE PARTNERSHIP PROGRAM ANNUAL REPORT AND LOCAL HOUSING INCENTIVES CERTIFICATIONS; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS** the State Housing Initiatives Partnership (SHIP) Program was created for the purpose of providing funds to counties as an incentive for the creation of local housing partnerships, to expand production of and preserve affordable housing, to further the housing element of the local government comprehensive plan specific to affordable housing, and to increase housing-related employment; and

**WHEREAS**, annually, Alachua County prepares a State Housing Initiatives Partnership (SHIP) Program Annual Report of its affordable housing programs and accomplishments; and

**WHEREAS**, annually, this Annual Report is reviewed by the Alachua County Affordable Housing Advisory Committee and is submitted to the Alachua County Board of County Commissioners for approval (“Board”); and

**WHEREAS**, pursuant to Section 420.9075(10), as part of or subsequent to the submission of the Annual Report, each county must submit a certification by its chief elected official or his or her designee that such Report is accurate and complete.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, AS FOLLOWS:**

**SECTION 1. Recitals.** The foregoing recitals are incorporated herein.

**SECTION 2. Resolution.** The Board authorizes its Chair to execute any certifications, including any supplements and amendments thereto, regarding and relating to the reporting for State Housing Initiatives Partnership (SHIP) Program and to submit to the State of Florida or Florida Housing Finance Corporation. The Board may revoke this delegated authority at any time.

**SECTION 3. Effective Date.** This Resolution shall become effective upon approval by the Board of County Commissioners of Alachua County, Florida.
