

**FIRST AMENDMENT TO AGREEMENT BETWEEN ALACHUA COUNTY AND WITH  
STRYKER SALES LLC, NO. 13974**

THIS First AMENDMENT (“Amendment”) is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the “County”) and STRYKERS SALES LLC, a Foreign Limited Liability Corporation which is authorized to do business in the State of Florida (“Contractor”), who are collectively referred to as the “Parties”.

**WITNESSETH:**

**WHEREAS**, the Parties previously entered into an Agreement dated December 15, 2023 for medical equipment service and maintenance, identified by No. 13974 (the “Agreement”); and

**WHEREAS**, the County has elected its option to renew the term of the original Agreement to allow the Contractor to furnish the goods or service to Alachua County; and

**WHEREAS**, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

**NOW, THEREFORE**, the County and Contractor agree to amend the Agreement as follows:

- A. Amendment. In accordance with the updated Stryker quote attached to the Amendment to term of the Agreement is extended through September 30 2025.
  
- B. Amendment. In accordance with the updated Stryker quote attached to the annual cost of the Agreement for the period of October 1, 2024 through September 30, 2025 is \$62,289.48
  
- C. Effective Date. This Amendment shall be effective upon execution by both Parties
  
- D. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
