**Description:**

Award and Agreement with Rogar Management and Consulting of FL, LLC (14503), for Bid 25-518-LC SW 20th Avenue Sidewalk from SW 43rd Street to SW 34th Street - LAP Project 9187907, for a total fiscal impact of \$1,740,316.20 (\$1,657,444.00 base bid plus \$82,872.20 contingency) for Public Works.

**Recommended Action:**

Approve the Award, adopt the resolution for unanticipated revenues and budget amendment, and authorize the Chair to execute Agreement 14503 with Rogar Management and Consulting of FL, LLC, for Bid SW 20th Avenue Sidewalk from SW 43rd Street to SW 34th Street - LAP Project 9187907, for a total fiscal impact of \$1,740,316.20.

October 9, 2018, the Board approved the FDOT Funding Agreements – SW 20<sup>th</sup> Ave Sidewalk, Poe Springs Rd Multi-Use Path and Animal Services Driveway. Item 36

**Fiscal Note:**

With approval of resolution for unanticipated revenue and attached budget amendment: the total budget for this project from FDOT will increase to \$450,619 in accounts 329.79.7910.541.63.01 and 341.79.7910.541.63.01 (Infrastructure Sidewalk/trails/signals) and the total budget from the County \$1,623,691 (from negotiation with City of Gainesville for Gas Tax proceeds) in account 341.79.7910.541.63.01 (Infrastructure Sidewalk/trails/signals).

**Background:**

Construct 5' wide concrete sidewalk along the north side of SW 20<sup>th</sup> Avenue between SW 43<sup>rd</sup> Street and SW 34<sup>th</sup> Street and two midblock crossings with rectangular rapid flashing beacons (RRFB's).

This project is being funded with Local Agency Program (LAP) monies granted to Alachua County.

Bid 25-518-LC SW 20th Avenue Sidewalk from SW 43rd Street to SW 34th Street - LAP Project 9187907 was released on June 25, 2025. The deadline for receipt of Bid 25-518-LC SW 20th Avenue Sidewalk from SW 43rd Street to SW 34th Street - LAP Project 9187907 was July 30, 2025; three (3) vendors responded.
