RESOLUTION 25 -95

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, AMENDING RESOLUTION 22-110 BY EXTENDING THE SUNSET DATE FOR THE HISTORICAL COMMISSION ADVISORY COMMITTEE; WHILE MAINTAINING THE OPERATIONS THEREOF; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners desires to utilize a Historic Commission Advisory Committee to assist and advise the Board of County Commissioners and those Departments designated by the County Manager in promoting, preserving and protecting Alachua County's historic resources, and interpreting Alachua County's cultural heritage;

and WHEREAS, on March 19, 1991, the Board of County Commissioners of Alachua County adopted Ordinance 91-3 re-establishing the Alachua County Historical Commission; and amended this on July 14, 2009 with Resolution 09-062 and on April 26, 2011 with Resolution 11-41; and on March 26, 2019 with Resolution 19-32; and

WHEREAS, on September 27, 2022, Resolution 22-110 extended the sunset date and repealed and replaced all prior resolutions in conflict with the terms set forth herein, except prior Resolution 09-062 requirements governing the Advisory Board not repealed continued; and

WHEREAS, the Board of County Commissioners wishes to extend the sunset date.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA:

Section 1. Resolution 22-110 is hereby amended as follows:

Section 2. The Alachua County Board of County Commissioners hereby re-establishes the Alachua County Historical Commission ("Advisory Committee") as a special committee. The sunset date for the Advisory Committee is December 31, ~~2022~~ 2030

Section 3. This resolution shall take effect immediately upon its adoption.
