### **Background:**

Local Workforce Development Board 9 (LWDB 9) oversees career center operations, provided by CareerSource North Central Florida (CSNCFL), in Alachua and Bradford Counties and receives funding by State program year (July 1-June 30) through formula, discretionary and dedicated grant purposes. LWDB9 received new funding for Welfare Transition Program (WTP) in the amount of \$83,879 for the period of October 1, 2022 to June 30, 2023, for Supplemental Nutrition Assistance Program (SNAP) in the amount of \$13,016 for the period of October 1, 2022 to September 30, 2023,

the Disabled Veterans Program (DVOP) in the amount of \$16,552 for the period of October 1, 2022 to December 31, 2024, the Local Veterans Program (LVER) in the amount of \$10,916 for the period of October 1, 2022 to December 31, 2024, the Trade Adjustment Assistance Case Management (TAA -CM) in the amount of \$1,800 for the period of October 1, 2022 to September 30, 2023, and the Trade Adjustment Assistance Training (TAA-T) in the amount of \$1,800 for the period of October 1, 2022 to September 30, 2023.
