

**FOURTH AMENDMENT TO AGREEMENT NO. 10217 BETWEEN ALACHUA COUNTY AND
PAUL STRESING ASSOCIATES INC FOR ANNUAL A&E SERVICES, RFP 17-35**

THIS FOURTH AMENDMENT TO AGREEMENT NO. 10217, made and entered into on _____, by and between Alachua County, a charter county and political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as "County", and Paul Stresing Associates, Inc., a Florida for profit corporation with a principle business address of 14617 Main Street, Alachua, Florida 32615 hereinafter referred to as "Professional". Collectively the County and the Professional are hereinafter referred to as the "Parties".

WITNESSETH:

WHEREAS, in 2016, the County issued Request for Proposal (RFP) #17-35 seeking proposals for Annual Architectural and Engineering Services for Capital Construction, Less than \$2,000,000.00 for Alachua County; and

WHEREAS, after evaluating and considering all timely responses to RFP #17-35, the County identified the Professional as one of the top ranked firms; and

WHEREAS, the Parties entered in the *Continuing Services Agreement for Annual Architectural and Engineering Services* dated February 28, 2017 (the "Agreement") with an initial Term ending September 30, 2017; thereafter renewed the Term of the Agreement for a one year period by entering into the First Amendment to the Agreement dated September 14, 2017 (the "First Amendment"); thereafter further renewed the Term of the Agreement for another one year period by entering into the Second Amendment to the Agreement dated September 25, 2018 (the "Second Amendment"); and thereafter further renewed the Term of the Agreement for another one year period by entering into the Third Amendment to the Agreement dated September 10, 2019 (the "Third Amendment"); and

WHEREAS, the County has elected to exercise its fourth and final renewal option to renew the Term of the Agreement for a one year period commencing October 1, 2020 through September 30, 2021; and,

WHEREAS, the Parties wish to amend the agreement to add a clause which defines and allows electronic signatures as set forth herein.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereby agree as follows:

A. SECTION # 1 of the Agreement, *Term*, is amended in its entirety to read as follows:

The County has elected to exercise its fourth and final option to renew the Term of the Agreement. Accordingly, the Term of the Agreement is renewed for the period of October 1, 2020 through September 30, 2021 (the “Fourth and Final Renewal Option Term”), unless earlier terminated as provided herein.

The County's performance and obligation to pay under this Agreement is contingent upon a specific annual appropriation by the Alachua County Board of County Commissioners (“Board”). The Parties hereto understand that this Agreement is not a commitment of future appropriations. Therefore, the continuation of this Agreement beyond the end of any fiscal year shall be subject to both the appropriation and the availability of funds in accordance with Chapter 129, Florida Statutes, and that the failure of the Board to do so shall not constitute a breach or default of this Agreement.

B. SECTION #37 of the Agreement, *Electronic Signatures*, the following new paragraph is added to the Agreement as follows:

The Parties agree that an electronic version of this Agreement shall have the same legal effect and enforceability as a paper version. The Parties further agree that this Agreement, regardless of whether in electronic or paper form, may be executed by use of electronic signatures. Electronic signatures shall have the same legal effect and enforceability as manually written signatures. The County shall determine the means and methods by which electronic signatures may be used to execute this Agreement and shall provide the Contractor with instructions on how to use said method. Delivery of this Agreement or any other document contemplated hereby bearing an manually written or electronic signature by facsimile transmission (whether directly from one facsimile device to another by means of a dial-up connection or whether mediated by the worldwide web), by electronic mail in “portable

document format” (“.pdf”) form, or by any other electronic means intended to preserve the original graphic and pictorial appearance of a document, will have the same effect as physical delivery of the paper document bearing an original or electronic signature.

C. This Fourth Amendment shall take effect upon execution by the Parties.

D. SAVE and EXCEPT as expressly amended herein, all other terms and provisions of the Agreement, as previously amendment, shall be and remain in full force and effect.
